13.2 DC-UOIT Academic Pathways Report 2015-2016

14.1 Provincial Key Performance Indicators (KPIs) – 2015-2016 Results

The 2015-2016 Provincial Key Performance Indicators (KPIs) were presented, noting employer satisfaction and graduation rate for the College are above the system average by 0.8% and 2.3% respectively while student satisfaction, graduate satisfaction and graduate employment are below the system average by 1.6%, 2.4%, and 0.4% respectively.

Three new programs of instruction were presented: Fire Science and Leadership (Ontario College Diploma), Massage Therapy (Ontario College Advanced Diploma) and Mechanical Technician – Elevating Devices (Ontario College Diploma).

14.4 Strategic Investment Fund Submissions

It was reported that the College is requesting funding under the Strategic Investment Fund for three projects including the Centre for Collaborative Education (Simcoe Building rebuild), the conversion of unused Simcoe Village Residence space and the conversion of two learning spaces at the Whitby Campus into a new food research lab.

Due to the deadline for submissions, the Executive Committee approved submission of the applications under the Federal Government's Strategic Investment Fund at its meeting held on May 2, 2016.

14.5 Local Employment Planning Councils

Governor McKee Demczyk provided an overview of the Local Employment Planning Councils pilot project being led by the Durham Workforce Authority in collaboration with Durham College and Region of Durham Social Services. It was reported that the College will be responsible for conducting the employer survey, which is a Durham-wide study intended to collect labour market information and local labour market intelligence. The College will develop and deploy the survey, analyze the data and encourage maximum participation in the survey.
