Implementation of the Program Health Matrix

President Lovisa and Judy Robinson provided an update to the Board on the implementation of the new program health matrix. This is a new tool introduced in spring 2010. Program health matrices were updated in March 2010 and distributed to the schools in May 2010. A template was provided for information, including sections for feedback include quality and growth. An overview of the program quality progress report was provided to the Board. The program team is asked to make a program report based on their annual curriculum review. Program quality reports will come forward to the Deans on June 18, 2010. Governor Spring commented that the new matrix is one example of the results of increased research resources at the College. Governor Dougherty commented that the information in this new tool allows us to further detail the true issues of KPI comments. The report was received for information.

NEW BUSINESS

Annual Report and Multi-Year Accountability Agreement

President Lovisa presented the draft annual report together with the Multi-Year Accountability Agreement Report to the Board for approval. Once approved, the report will go to final publication. We have achieved the majority of targets of our business plan for the year. The report celebrates our success and mirrors our strategic plan "our students, our people, our business, our community", while highlighting our strategic framework together with key goals and community outreach events at Durham College.

The Durham College Multi-Year Action Plan 2006-2009, submitted in 2006 to MTCU, committed the College to specific multi-year strategies, performance indicators and results relating to the goals of the access, quality and accountability, as articulated in the ministry's "Reaching Higher Plan". As an accountability measure, colleges are required to submit a Multi-Year Accountability Agreement (MYAA) Report Back to MTCU on an annual basis. The Report Back measures the college's achievement in meeting the commitments identified in the Multi-Year Action Plan 2006-2009. We have received word that MTCU has extended the deadline for this report to September 30, 2010.
